

Terms and Conditions of Mind Skills Mastery Laser Coaching

Contract Period

The Contract shall be in force for the 3- or 6-month period paid for and up to the agreed number of weekly sessions from the date of this payment.

By investing in this program, you agree and accept the terms and conditions of this contract. Your payment acknowledges your agreement.

The Services

The Coach shall assist the Client in clarifying his/her personal goals, and in working out a plan of action, as determined by the Client, to help achieve such goals. The Coach will accomplish this by carefully listening to the Client's concerns, providing open, honest feedback, and asking questions intended to elicit responses from the Client that will lead him/ her to decide and agree what steps to take to achieve the desired results.

The steps and actions must be completed before booking the next session.

The Services will be delivered by zoom, for a period of 20 minutes once each week, at a mutually-agreed time. The schedule may be modified, if necessary, and if both Parties agree to such modification.

The first session will be 45 minutes to establish long term goals and a proposed direction for the next period of time agreed to.

The Client will receive a recording of the Laser Coaching session with the client's permission.

The Client may terminate the Services at any time with 4 weeks notice of termination, with no further obligation.

Confidentiality and Limit of Liability

Any information divulged to the Coach by the Client shall remain completely confidential, except in the event of the Coach's knowledge of any illegal activity by the Client, or admission by the Client of the intent to commit an illegal act.
